(The taking of photographs in the photography area WILL BE RESTRICTED TO THE OFFICIAL PHOTOGRAPHER AND WILL BE STRICKLY ENFORCED.)

Photographs of wins & of candid photos of dogs being exhibited may ONLY be taken by authorized show photographer(s).

EXHIBITORS PLEASE NOTE

JUDGING: No dogs will be allowed in the show area except those regularly entered in the Show. DO NOT BRING DOGS THAT ARE NOT ENTERED. There are no provisions for unentered dogs. The judging will start promptly. Dogs may arrive prior to their time of judging, and may leave immediately thereafter, unless required for further judging. The Club and its Show Secretary will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

LOSS OR DAMAGE: The Show Committee will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible or assume any liability at this Show. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children at the Show.

SMOKING: No smoking including vaping will be permitted within 30 feet of any building or door.

COVID PROTOCOLS: Subject to change without notice. We will adhere to the latest COVID-19 guidelines according to the State of Virginia and the Federal CDC recommendations which are in place at the time of our show.

CLEANING UP AFTER YOUR DOG: This is YOUR responsibility.

NO OUTSIDE FOOD ALLOWED IN THE BALLROOM. There are restaurants in the hotel for your food and drink needs.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snowstorms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
