


ROUTES TO THE TRIAL

From I-70, take I-270 South, or from I-71, take I-270 East. Exit I-270 at Exit 49 (Alum Creek Drive). Go North approximately 1 mile on Alum Creek Drive and turn Left on Williams Road. (There is a traffic light at this intersection.) Go approximately 1/4 mile to the CATC facility on the right side of the road (2164 Williams Road). Speed limits strictly enforced on Alum Creek Drive.

When relieving or exercising your dog, always maintain a 6' distance.
