DIRECTIONS TO SHOW SITE

From the South:

Take 270 North towards Cleveland. At exit 30, 33, take ramp right for OH-161 East toward New Albany. Take ramp to right for US 62 to-ward New Albany/ Johnston. Turn left onto US 62 East/Johnstown Rd. Turn Left onto Tippet Rd. (Name of road changes to S County Line Road). Turn Left onto Robins. Turn Left to destination.

From the West:

Take 270 East. (Name of road changes to 270 South). Take Exit 30 ramp on right for OH-161 East toward New Albany. Take ramp to right for US 62 to- ward New Albany/Johnston. Turn left onto US 62 East/Johnstown Rd. Turn Left onto Tippet Rd. (Name of road changes to S County Line Road). Turn Left onto Robins. Turn Left to destination.

Due to limited parking available, please do not plan to arrive earlier than one hour before your class as noted in the judging program after entries close.

NOTICE TO EXHIBITORS *** PLEASE READ ***

Send completed entry forms (including both the sides of the official AKC entry form) with correct fees to: GRCCO c/o MAC Dog Shows / Mary Mignogna, 5612 Norquest Blvd, Austintown OH 44515. Entry forms MUST be signed. Entries unsigned or mailed in without both sides of the official AKC entry form will NOT be accepted. Postdated checks will not be accepted. Please fill out the entry form legibly. Make checks or money orders payable to MAC Dog Shows LLC.

Confirmations will be emailed.

We cannot guarantee on-time arrival of entries sent via FedEx or other overnight service. Be sure to check the signature waiver box on your mailing form.

The term "dog" means either dog or bitch.

Entries received after the trial fills but before the closing date, will be put on a Waiting List. If you are on the Waiting List & do not get into the show, your entry check will be shredded. If your entry is accepted & you pull your dog before closing date, your check will be shredded. If you pull your entry after the closing date, & an alternate from the Waiting List fills your spot, you will receive a full refund.

Any exhibitor whose bitch has come in season, or any dog which has incurred an injury after the closing date, may obtain a refund of the entry fee (less \$6.00 for administration expenses per entry) upon presentation of a Veterinarian's certificate to the Trial Secretary prior to the state of the trial.

NOTE: There will not be any refunds of entries AFTER closing date except for the above reason. No refunds or overpayments of \$6.00 or less. Refunds will be mailed after the trials.

Bounced checks are subject to a fee of \$30.00.

The handler is solely responsible for having the dog at ringside when scheduled. Judges are not required to wait for any dog holding up a class. Dogs need be at the trial only at scheduled time of judging & may leave immediately after, unless required for further judging.

If, because of riots, civil disturbances, or other acts beyond the control of GRCCO, it is impossible to open or to complete the trial, no refund of entry will be made. GRCCO will not be responsible for loss or damage to property while on show site.

No entry will be accepted which carries any conditions regarding its acceptance.

GRCCO will not be responsible for errors made on entries. Please double check entry prior to sending. Owners are responsible for errors. No entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.

Entries received without fees will not be accepted. Unsigned checks & returned checks do not constitute payment of fees.

There will be an AKC Service Fee of 4.50 & an AKC Recording Fee of \$0.50 per entry in the Rally Trial. If a dog is entered in more than one class, the fee is collected on all classes the dog is entered in, excluding non-regular classes. This fee is to be collected by the show giving club & paid to the AKC. *These fees are already included in the posted entry fee.*

All dogs must be kept on leash or crated at all times, except as allowed in the Show Ring. NO FLEXI LEADS ALLOWED INSIDE SHOW SITE.

The Show Site will open 1-hour prior to the start of the event & will close 1-hour after the event.

Transfers will be allowed for these trials. All transfers will run at the end of their class, jump height. Transfers must be received at least 30 minutes prior to the start of each trial.

Breakfast food items will be available all 3 days of these trials. A Potluck lunch will be served Saturday, midday, for exhibitors and volunteers. Donations will be gladly accepted.

Parking is limited!!! Please plan to park so there is room for everyone.

Crating space is limited, so if needed, you may be asked to consolidate crating so everyone can have a space. Bringing unentered dogs is discouraged, but if they come along, you may be asked to crate them in your car.
