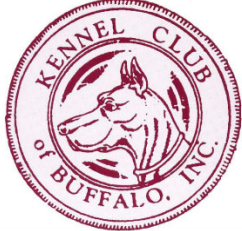

~ **Online payments will be accepted thru STRIPE.** Email ([MACDogShows@outlook.com](mailto:MACDogShows@outlook.com)) or fax (330-599-7185) your entry form(s) to Mary asking for an Invoice through STRIPE. This will allow you to pay online. A convenience fee of \$4.00 will be included per dog / per event number. Your entry will not be accepted until full payment is received.

~ **NOTE:** If you pay via Stripe and you withdraw your entry prior to the closing date, you will receive a full refund of your entry fee except for the convenience fee.

~ A Waiting List will be established IF the numerical number of entries is reached. The Waiting List will only be maintained until the trial closing date.

~ Entries must be received by 12:00 pm, EST Wednesday June 25, 2025 after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the AKC.

~ All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient funds will have their entry cancelled, acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express deliveries must include a signature waiver permitting them to be left at the Secretary's address without a receipt signature.

**Entries received without signature waiver will be returned.**

~ Entries **MUST INCLUDE A LEGIBLE EMAIL ADDRESS** so that an acknowledgement can be sent as well as the judging program and armband assignment. The secretary is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be sent after closing.

~ **Refunds:** Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that the dog is absent, disqualified, excused by the veterinarian, or judge or barred for competition by the Trial Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Trial Committee makes it impossible to open or complete the show/trial. Refunds will be made, less \$5 per entry, **for bitches entered who come into season after the closing date** if notification is made to the secretary at least 30 minutes prior to the start of the show.

~ **Entry Errors:** Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors corrected prior to closing. Exhibitor errors discovered after closing cannot be corrected. Overpayments of less than \$5 per dog will not be refunded.

~ **Catalogs:** Only a limited number of catalogs will be printed. To be sure you receive a copy, prepay for your catalog by including \$4.00 with your entry fee. To receive your prepaid catalog, give your name to the Trial Secretary. Only 5 catalogs will be available at the trial at a cost of \$5.00. No catalogs will be mailed.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e.,Cocker Spaniel (solid color black, ASCOB, parti-color). Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.). Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles & Ruby, Blenheim & Prince Charles), Poodles (toy, miniature, standard).

The following categories of dogs may be entered & shown in Best of Breed competition; Dogs that are Champions of Record & dogs which, according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

(Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
