### ENTRIES:

- ~ Entries will be accepted in the order they are received.
- ~ **ONLINE ENTRIES** can be made at <https://www.macdogshows.com/online-entries>. You will be asked if you will be paying by check or wish for a STRIPE invoice to be sent. If you enter through STRIPE, a \$4.00 convenience fee will be charged. The \$4.00 convenience fee is **per dog, per entry**.
- ~ **NOTE:** If you pay via STRIPE and you withdraw your entry prior to the closing date, you will receive a refund of your entry fee except for the convenience fee(s).
- ~ A Wait List will be established IF the hours of judging is reached. The Wait List will only be maintained until the trial closing date. An email will be sent to the exhibitor(s) if they did not get into the trial.
- ~ Both RACH & RAE classes are offered. Once the hour limit has been reached in either the Master, Excellent B, or Advanced B classes, these classes will be considered closed.
- ~ The UDX class is offered. Once the hour limit has been reached in either the Utility B or Open B classes, the UDX class will be considered closed.
- ~ Please indicate on your entry form if you are entering the RACH, RAE, or UDX class.

### COVID-19:

- ~ Although we will not require a COVID release for our trials, we do ask that you respect our workers, judges, & your fellow exhibitors & ask that IF you are not feeling well or have tested positive for COVID, that you not attend our trials.
- ~ If the State of Ohio, Cuyahoga County, or the CDC make any significant changes at the time of our trials, we will make you aware of our trial changes in the judging program and/or email.

### NO SMOKING:

- ~ NO smoking within 30 ft of any building which includes the doors or inside the building. This includes e-cigarettes, vapes, etc.

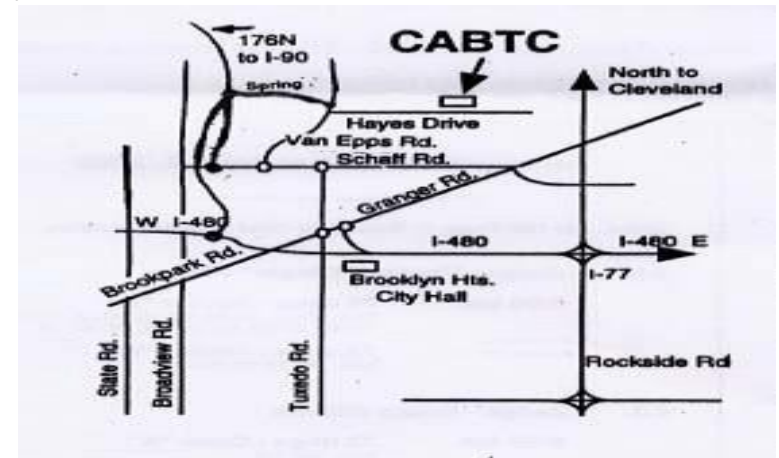
### \*\*\*\* DIRECTIONS TO SHOW SITE \*\*\*\*

**From the West:** Take the Ohio Turnpike. Get off at Exit 151 to I-480 East. Take I-480 East to Route 176 North. From Route 176 North. The very next exit is Spring Road/Hinckley Parkway. Turn right onto Spring Road/Hinckley Parkway. From Spring Road/Hinckley Parkway: Turn left on to Spring Road. Spring Road dead-ends at Van Epps (at the stop sign). Make a very slight right turn onto Van Epps. The next street is Hayes Drive. Turn left on to Hayes Drive. Note: if the blue Brilliant Electric Sign Co. sign is to your left, you have gone too far.

**From the East:** via the Ohio Turnpike to Exit 173 - the I-77 exit. Follow the signs to I-77. Take I-77 North to I-480 West. Immediately get off at the Route 176 North/Brookpark exit. Stay on Route 176 North & then follow above directions.

**From the South (& hotels):** Take I-77 North to I-480 West. Immediately get off at Route 176 North/Brookpark exit. Stay on Route 176 North & follow above directions from Route 176 North.

## TRIAL REGULATIONS

**ENTRIES CLOSE AT THE TRIAL SECRETARY'S OFFICE**, by 6:00pm, Wednesday, February 14, 2024, after which time entries cannot be accepted, altered, canceled, or substituted. Make check payable to MAC Dog Shows LLC. Canadian exhibitors must have fees payable in US Funds **RETURNED CHECKS** do not constitute a valid entry fee. The Trial Secretary will add a collection fee to the amount of **\$40 to each returned check**.

**ENTRY FORM MUST BE SIGNED** by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted.

**OVERNIGHT deliveries** requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement & Rules on the reverse side of the official AKC Entry Form are **NOT ACCEPTABLE**.

**A RECORDING FEE OF \$50** is to be collected on the first entry only for each dog, each day.

**An Event Service fee of \$3.00** will be required for each regular class each dog is entered at any Licensed or Member Club Show, Obedience Trial, Rally Trial or Tracking Test. These Fees are to be collected by the show giving Club & paid to the AKC. (AKC Rule, Chapter 11, Section 2).

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competing by action of the Trial Committee.

**DOGS MAY ARRIVE ONE HOUR PRIOR** to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.

**NO ENTRY FEES WILL BE RETURNED** if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the management.

**OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors.

**DECLINATION OF ENTRIES, GSDC of Northern Ohio Inc**, may decline any entries & may remove any dog on account of disease, viciousness, or other cause & no one shall have any claims against GSDC of Northern Ohio, Inc. or any official thereof.

**NO ENTRY SHALL BE MADE** & no entry shall be accepted which specifies any conditions as to its acceptance.

**WHEN THE SAME DOG IS ENTERED** in more than one class, only the highest score will be used for the top awards in Trial or top awards of a breed.

**DOGS NOT REQUIRED FOR FURTHER JUDGING** will be excused. Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
