This will allow you to pay online. A convenience fee of \$3.00 will be included per dog. Your entry will not be accepted until full payment is received.

- A Waiting List will be established IF the numerical number of entries is reached. The Waiting List will only be maintained until the trial closing date.
- Entries must be received by 6:00 pm, EST Wednesday June, 21, 2023 after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.
- All entries must be on official AKC entry forms. Entries will be returned if they are illegible, Incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient funds will have their entry cancelled, acceptance of such an entry will be only be made if the full fees, plus a \$25 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without a receipt signature. Entries received without signature waiver will be returned.
