- ~ A Waiting List will be established IF the numerical number of entries is reached. The Waiting List will only be maintained until the trial closing date.
- ~ Entries must be received by 6:00 pm, EST Wednesday June, 21, 2023 after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.
- ~ All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient funds will have their entry cancelled, acceptance of such an entry will be only be made if the full fees, plus a \$25 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without a receipt signature. **Entries received without signature waiver will be returned.**
- ~ Entries **MUST INCLUDE A LEGIBLE EMAIL ADDRESS** so that an acknowledgement can be sent as well as the judging program and armband assignment. Secretary is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be sent after closing.
- ~ **Refunds:** Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that the dog is absent, disqualified, excused by the veterinarian, or judge or barred for competition by the Trial Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Trial Committee makes it impossible to open or complete the show/trial. Refunds will be made, less \$5 per entry, **for bitches entered who come into season after the closing date**, if notification is made to the secretary at least 30 minutes prior to the start of the show.
- ~ Entry Errors: Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors corrected prior to closing. Exhibitor errors discovered after closing cannot be corrected. Overpayments of less than \$5 per dog will not be refunded.
- ~ **Catalogs:** Only a limited number of catalogs will be printed. To be sure you receive a copy, prepay for your catalog by including \$4.00 with your entry fee.
