## DIRECTIONS TO SHOW SITE

**From the South:** (NYC and New Jersey): I-87 North (NYS Thruway) to Saugerties Exit 20, then right onto Route 212 East, then right onto Kings Highway for 3 miles, then right onto Industrial Drive. Dream Dogs Training Center is on the left. Cars keep to the right when entering.

**From the North:** (Albany and Western Massachusetts) I-87 South (NYS Thruway) to Saugerties Exit 20. Turn left onto Route 32 South, then turn left onto Route 212 East, then turn right onto Kings Highway. Follow for 3 miles, then turn right onto Industrial Drive and follow to the end.

## JUNIOR SHOWMANSHIP & PEEWEE JUNIOR SHOWMANSHIP ~ AT ALL SHOWS ~

AKC Junior Handler Numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club - Phone: 919-233-9767. For additional information contact American Kennel Club, Junior Showmanship, PO Box 900051, Raleigh, NC 27675-9051. Phone 919-233-9767 or E-mail: juniors@akc.org. Entry form MUST be filled out with the necessary junior's information, otherwise the entry in Junior Showmanship will not be accepted. BITCHES IN SEASON ARE NOT PERMITTED.

### Junior Showmanship Regulations

Entry fees are \$10 for Junior Showmanship as a first entry for the dog  
or FREE as a second entry for the dog.

**NOVICE JUNIOR CLASS:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

Junior Handlers who win a third Novice Class with competition present or a first place in Novice without competition leading to a Best Junior award with competition, would count as one win towards moving to Open, after the closing of entries for a show, **ARE REQUIRED TO TRANSFER** their entry from the Novice Class to the Open Class. **MUST NOTIFY THE SHOW SECRETARY** at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.



## PeeWee Junior Showmanship Regulations

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one PeeWee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult. At an All-Breed Event the judge must be an AKC approved All Breed Junior Showmanship Judge. A Group Club or Specialty Club may have a Limited Status Junior Showmanship Judge that meets the criteria. The Judge MUST like children, be patient, kind, and have a sense of humor!

This Special Attraction must be listed as such in the premium list and in any public announcements which will include the following information:

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- At a Group or Specialty Club Show the dogs must be of the breed(s) eligible for the event.
- At an All-Breed event, all AKC fully recognized and Miscellaneous Class breeds must be allowed to enter, including dogs with a PAL listing.
- At an All-Breed event, it is up to the host club to decide if FSS breeds not in the Miscellaneous Class and All-American dogs are allowed to enter.
- It is up to the host club to decide if a dog must be registered to participate.
- How entries will be accepted is up to the host club. In addition to an entry, a release must be signed by the child's parent or legal guardian. Please contact Event Operations at [eventplans@akc.org](mailto:eventplans@akc.org) to request the current version of the Pee Wee Release of Liability.
- The entry fee, if any, shall be specified. **Entry fees are FREE for PeeWee Junior Showmanship !!!**
- Clubs may specify a limit on the number of children allowed to enter the class.
- Clubs must submit a summary report to AKC including number of entries and feedback to the Event Operations Department at [eventplans@akc.org](mailto:eventplans@akc.org).
- The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

### **Non-Regular ~ Single Dog Classes (for dogs & bitches)**

#### **NON-REGULAR CLASSES FOR SINGLE DOG ENTRIES**

**Veteran Classes:** Are open to all Salukis seven (7) years old and over on the day of the show. Judging will take place after regular Dog or Bitch classes, prior to Best of Breed Judging. While a Champion may be entered in both Veteran and Best of Breed classes, a dog must be undefeated to enter the BOB ring. Remember, a dog NOT winning the Veteran Class is ineligible to compete in BOB, even if it is entered.

**NOTE:** Neutered dogs and spayed bitches would be allowed to compete in Veterans and all other single entry non-regular classes only at independent specialties and/or those all-breed shows which do not offer any competitive classes beyond Best of Breed.

These are each independent Specialties. Winners of these Veteran Classes are eligible to compete in the Best of Breed ring.

**Coursing Dog and Bitch Classes:** Are open to Salukis who have earned an ASFA FCh, OFC Title, or an AKC FC. Because the winners of the class will compete for Best of Breed, all entrants must also meet ALL American Kennel Club Requirements for Non-Regular Classes involving single dog entries. Proof of non-AKC coursing championship titles must be provided with entry.

#### **NON-REGULAR ~ MULTIPLE DOG CLASSES**

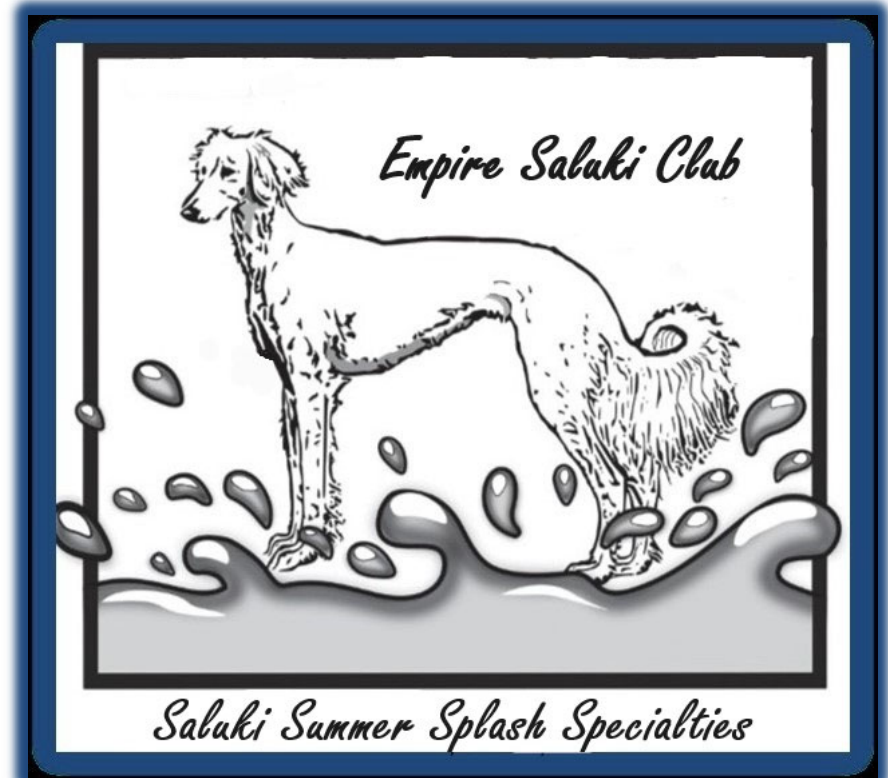
**Stud Dog Class:** For Stud Dogs and two (2) of their get. It is not necessary that all Get be under the same ownership as that of the Stud Dog. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with his Get. The Stud Dog may be entered separately in one of the Regular or Non-Regular classes at the normal entry fee, with Stud Dog class indicated on the entry form in the space for additional classes at an additional \$20 for the Stud Dog class. Or the Stud Dog may be entered in Stud Dog Class ONLY for a \$25 entry fee.

- The Get MUST be entered in one of the Regular Classes, but there is no additional entry fee for them as participants with their sire in this non-regular class. The merits of the Stud Dog are not considered in the placement of the entry. The Get only will be judged on the merits of the Get. Therefore, the winners of these classes are NOT eligible to compete for Best of Breed or for Best of Opposite Sex to Best of Breed.
- Get are NOT named on the entry form.
- All Get must be examined and gaited.

- While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or being excused under the Dog Show Rules, AKC policy or the standard for the Breed.
- **NOTE:** AKC Rules Applying to Dog Shows Chapter 11 Section 8 "A castrated male may be entered as Stud Dog in the Stud Dog Class and a spayed bitch may be entered as Brood Bitch in the Brood Bitch Class."

**Brood Bitch Class:** Same as Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

**Brace Class:** Effective January 1, 2005. A Brace is defined by the AKC as two (2) dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in Brace competition must have at least one common owner. **The dogs comprising the Brace must be named at the time of the entry.** Entry fee is \$25 for the pair. Specify "Brace Only" on each dog's entry form. If either dog that is to be part of a Brace is entered in another class, specify "Brace" in the "Additional Class" section on the entry form; the fee is \$20 for the pair. Neither of the dogs in the pair is required to be entered in a regular class.

**AKC NATIONAL OWNER-HANDLED SERIES (NOHS)**

*Remember to check the box at the bottom of the entry form to participate - or, if entering on-line check the Owner-Handled box.*

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

- All dogs that are owner-handled and are not solely owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is "Owner-Handled" eligible at the time of entry on the entry form. Eligible dogs will be indicated with an asterisk in the Steward's book, Judge's Book, and the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in this competition.**
- Owner-Handled Best of Breed/Variety will be selected from the dogs that are eligible to compete in the Best of Breed/Variety competition including Winners Dog, Winners Bitch, and winners of the non-regular classes. **However -**
- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed/Variety nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed/Variety including Winners Dog or Winners Bitch as the Best of Breed/Variety for the AKC National Owner-Handled Series.
- If the Best of Winners is eligible, the other Winners are ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.
- The breed will not be represented in the Owner-Handled Group (for an all-breed show) if there is no eligible dog competing in the Best of Breed / Variety or in Best of Winners competition.

Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

## **SHOW REGULATIONS**

- **ENTRIES CLOSE AT THE SHOW SECRETARY'S OFFICE**, at 5:00pm, Thursday, July 3, 2025, after which time entries cannot be accepted, altered, canceled, or substituted. Make check payable to MAC Dog Shows LLC. Canadian exhibitors must have fees payable in US Funds.
- **RETURNED CHECKS** do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of \$40 to each returned check.
- **ENTRY FORM MUST BE SIGNED** by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted.
- **OVERNIGHT deliveries** requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement & Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE.
- **An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 for first entry and \$3.50 for each additional entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.50 for each additional entry in any Licensed or Member Club Rally Trial. An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show.** All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.) These fees are to be collected by the show giving Club & paid to the AKC. (AKC Rule, Chapter 11, Section 2).
- **ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competing by action of the Trial Committee.
- **DOGS MAY ARRIVE ONE HOUR PRIOR** to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.
- **NO ENTRY FEES WILL BE RETURNED** if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the management.
- **OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors.
- **NO ENTRY SHALL BE MADE** & no entry shall be accepted which specifies any conditions as to its acceptance.

The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
- **DOGS NOT REQUIRED FOR FURTHER JUDGING** will be excused.
- **ALL AWARDS MUST BE CLAIMED** at the Show, or they become the property of The Empire Saluki Club. None will be mailed.
- **ALL DOGS PRESENT MUST BE HELD ON LEASH** or confined to their crates except when being judged or when in the exercise ring.
- All exhibitors, owners, and/or handlers are asked to clean up after their own dog.
