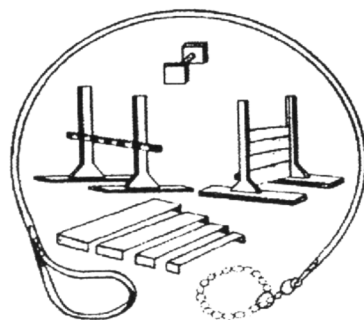

****** DIRECTIONS TO SHOW SITE ******

From West: Take I-76 East to the Bailey Road exit. Turn South (right) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. The trial site is about one mile on the right hand just past the blue water tower.

From East: Take I-80 West which will merge with I-76 West. Proceed two miles after the merger to the Bailey Road exit. Turn South (left) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. The trial site is about one mile on the right-hand side just past the blue water tower.

From Ohio Turnpike: Take the Turnpike to Exit 218. At the exit, follow signs to Mahoning Avenue. Proceed to Mahoning Avenue West. At the light (Route 45), continue on Mahoning Avenue crossing over Bailey Road. The trial site is located on the right-hand side just past the blue water tower.

OR ~ at Exit 218, take I-76 West (Akron) to Bailey Road. Turn South (left) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. The trial site is about one mile on the right-hand side just past the blue water tower.
