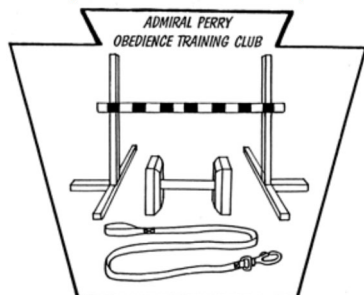

ENTRIES:

- ~ Entries will be accepted in the order they are received. Entries are not processed until full payment is received ... whether mailed, faxed, or entered online. Full payment constitutes an entry.
- ~ **ONLINE ENTRIES** can be made at <https://www.macdogshows.com/online-entries>. You will be asked if you will be paying by check or wish for a STRIPE invoice to be sent. If you enter through STRIPE, a \$4.00 convenience fee will be charged. The \$4.00 convenience fee is **per dog, per day entered**.
- ~ **NOTE:** If you pay via STRIPE and you withdraw your entry prior to the closing date, you will receive a refund of your entry fee except for the convenience fee(s).
- ~ A Wait List will be established IF the numerical limit or hours of judging are reached. The Wait List will only be maintained until the trial closing date. An email will be sent to the exhibitor(s) if they did not get into the trial. If you paid by STRIPE and do not get into the trial, a full refund and the convenience fee(s) will be refunded.
- ~ Both RACH & RAE classes are offered. Once the numerical limit has been reached in either the Master, Excellent B, or Advanced B classes, these classes will be considered closed.
- ~ The UDX class is offered. Once the hour limit of judging has been reached in either the Utility B or Open B classes, the UDX class will be considered closed.
- ~ Please indicate on your entry form if you are entering the RACH, RAE, or UDX class.
- ~ Entries will be acknowledged via email when they are received and processed. Please review and respond if any changes are noted.
- ~ Armband numbers and judging programs are sent via email for all entries received. This will be done once the trials are closed, and the judging assignments are complete. Should such acknowledgment not be received within a reasonable time, please notify the Trial Secretary at 330-518-9920 or MACDogShows@outlook.com.

REFUNDS:

- ~ Refunds will be given for entries withdrawn in writing or via email before the closing date and time.
- ~ If a bitch comes in season after the trials close, a refund less \$15.00 will be refunded to the owner. In order for the refund to be given, the owner needs to provide a signed statement from a veterinarian on office stationery along with the request for such a refund at least 30 minutes before the start of the trial.

NO SMOKING:

- ~ NO smoking within 30 ft of any building which includes the doors or inside the building. This includes e-cigarettes, vapes, etc.

- ~ **Mats need to be under all crates and chairs.**
- ~ NO private exercise pens will be allowed.
- ~ Exhibitors/Handlers will be responsible for clean conditions in and around their dog's crate.

TRIAL REGULATIONS

ENTRIES CLOSE AT THE TRIAL SECRETARY'S OFFICE, by 6:00pm, Wednesday, July 29, 2026, after which time entries cannot be accepted, altered, canceled, altered, or substituted. Make check payable to **MAC Dog Shows LLC**. Canadian exhibitors must have fees payable in US Funds **RETURNED CHECKS or credit card payments which are subsequently disputed, ARE NOT valid payment of entry fees**. An additional **\$25 fee plus bank charges will be added to each returned check** and the exhibitor will be expected to make payment in full.

ENTRY FORM MUST BE SIGNED by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted.

OVERNIGHT deliveries requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement & Rules on the reverse side of the official AKC Entry Form are **NOT ACCEPTABLE**.

ENTRY FEE INCLUDES AN AKC RECORDING FEE OF \$0.50 for every dog entered. The **AKC Event Service fee of \$4.00** will be required for each first entry of a dog in Obedience and Rally. The AKC Event Service fee of \$4.50 will be required for each additional entry of the same dog in regular and non-regular classes. These fees are included in the entry fee. (AKC Rule, Chapter 11, Section 2 [Effective 01/01/2026]).

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competing by action of the Trial Committee.

DOGS MAY ARRIVE ONE HOUR PRIOR to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.

NO ENTRY FEES WILL BE RETURNED OR REFUNDED for errors on an entry form, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club.

OWNERS ARE RESPONSIBLE for errors in making out entry forms, whoever may make such errors, & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors.

DECLINATION OF ENTRIES, Admiral Perry Obedience Training Club, Inc., may decline any entries & may remove any dog on account of disease, viciousness, or other cause & no one shall have any claims against Admiral Perry Obedience Training Club, Inc. or any official thereof.

DOGS NOT REQUIRED FOR FURTHER JUDGING will be excused. Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL AWARDS MUST BE CLAIMED at the Trial, or they become the property of Admiral Perry Obedience Training Club, Inc. None will be mailed.

ALL DOGS PRESENT MUST BE HELD ON LEASH or confined to their crates except when being judged or in designated warm-up areas. No flexi-leashes or prong collars permitted in the buildings. All owners and handlers are asked to clean up after their own dog.
