

For Scottish Deerhounds that have placed in a Regular Stake at an AKC sanctioned Field Trial.

### Non-Regular (additional) Classes involving multiple dog entries

(Not eligible for Best of Breed)

#### BEGINNER PUPPY 4-6 MONTHS

The Four-to-Six Month Puppy competition shall be for dogs that are four (4) months of age and over, but under six (6) months on the day of the event. AKC registration number or an AKC litter number will be required for entries. A foreign-born dog may enter this class if they are registered in the Country of origin. Professional handlers, members of their household, current assistants to professional handlers may personally exhibit a dog they own as

"Exhibition Only" in the Four-to-Six Month (Beginner Puppy) competition. "Exhibition Only" entries are not eligible to earn awards in this competition.

Dogs that are owned or co-owned by the forenamed a professional handler, member of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five (5) years. Dogs may not be exhibited by current assistants and household members of a professional handler.

- Minors (under 18 years of age) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) competition.
- Exhibition Only entries may not be changed to be eligible to compete for awards after the close of entries.

### **STUD DOG / BROOD BITCH**

A class with the Stud Dog / Brood Bitch and two (2) and not more than four (4) of their get/produce. Stud Dog / Brood Bitch must be entered on the regular entry form as an additional class. Stud Dog / Brood Bitch must be shown in the ring with their get/produce. Owner of Stud Dog / Brood Bitch need not necessarily be owner of the get/produce. The class will be judged on the merits of the get/produce. Judging of this class will be after Best of Breed class.

### **BRACE**

This class is for two (2) dogs that are similar in appearance, performing in unison, and presented by a maximum of two (2) handlers (can be one (1) handler). Both dogs competing in Brace competition must have at least one (1) common owner. Both dogs must be entered in a regular class. Judging of this class will be after Best of Breed class. Brace class must be entered on the regular form as an additional class.

### **TEAM**

This class is for four (4) dogs that are similar in appearance, performing in unison, and presented by a maximum of two (2) handlers (can be one (1) handler). The dogs competing in Team competition must have at least one (1) common owner. The dogs must be entered in a regular class. Judging of this class will be after Best of Breed class. The Team class must be entered on the regular form as an additional class.

**NOTE:** As the judge's decision is based on more than one dog or bitch, none of the dogs or bitches making up the entry in these classes will be eligible to compete in Best of Breed by virtue of having won these classes.

### **BEST PUPPY COMPETITION**

During the course of the regular judging, the assigned judge will select a Best Puppy from the Puppy Class winners. This will be done after the Best of Breed competition, unless the Best Puppy award is automatically awarded. Example: An entry from the Puppy Class is awarded Best of Winners or Best of Breed. Only dogs and bitches undefeated in a Puppy Class are eligible for Best Puppy competition. If the first-place winner is not present, the second place winner may not compete. No additional fee is required. All Puppy Class winners (6-9 months, 9-12 months, and Bred-By 6-12 months) are eligible to compete.

### **BEST BRED-BY COMPETITION**

During the course of regular judging, the assigned judge will select a Best Bred-By Exhibitor (BBE) from the Bred-By Exhibitor class winners. This will be done after Best of Breed Competition unless the award is automatic. Example: An entry from the BBE class is awarded Best of Winners or Best of Breed. Only dogs and bitches undefeated in BBE class are eligible for Best Bred-By Exhibitor competition. If the first-place winner is absent, the second place winner may not compete. The dogs and bitches in Bred-By Exhibitor (Puppy) and Bred-By Exhibitor (Adult) will compete for Best Bred-By Exhibitor. No additional fee is required.

### **JUDGES AWARD OF MERIT**

The judge may, at their discretion, choose up to five (5) entrants that show exceptional quality deserving of an Award of Merit, excluding Best of Breed, Best of Opposite Sex to Best of Breed, Winners Dog and Winners Bitch based on the number of entries in the BOB Class as follows:

Up to 1 AOM if 8 to 12 dogs shown

Up to 2 AOM if 13 to 17 dogs shown

Up to 3 AOM if 18 to 22 dogs shown

Up to 4 AOM if 23 to 27 dogs shown

Up to 5 AOM if 28 or more dogs shown

### **BEST VETERAN COMPETITION**

Best Veteran will be selected from the regular Veteran Dog and Veteran Bitch classes following the judging of Best of Breed and Award of Merit competition. Only dogs not defeated in regular Veteran Class are eligible to compete.

## NOHS ~ NATIONAL OWNER HANDLED SERIES

*The purpose of the AKC National Owner Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/ handlers to compete against their peers. The determination of the awards in the AKC National Owner Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.*

- There is no additional fee to enter this competition.
- **Entries must be marked as eligible to compete in the AKC NOHS or entered in the Amateur-Owner-Handler class prior to the closing of entries for that show.** Entries into the Amateur-Owner-Handler class are automatically entered into the NOHS.
- The handler must be an owner of record according to the AKC's records as of the date of the show.

### Eligibility

- Professional handler, household members, and current assistants to professional handlers in conformation are not eligible to exhibit in this competition. A current assistant is defined as anyone employed by a professional handler on a full time basis or assisting a professional handler at the show or any show during the cluster/weekend.
- Current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.
- Professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition.
- Eligibility restrictions apply to all members of the same household.

## POINTS FOR RESERVE WINNERS DOG AND RESERVE WINNERS BITCH

**NATIONAL SPECIALTY ONLY:** Scottish Deerhound Club of America as provided by the American Kennel Club will designate the Reserve Winners Dog and the Reserve Winners Bitch to be awarded a three (3) point major, provided that the number of dogs competing in the regular classes of the Reserve Winners sex totals at least twice the number required for a five (5) point major, in the region in which this event is held. No Major for Reserve Winners shall be given based upon an award of Best of Winners. In counting the number of dogs in competition, a dog that is disqualified, or that is dismissed, excused, or ordered from the ring by the judge or from which all awards are withheld, shall not be included.

## ADDITIONAL CLASSES

### 3 GENERATIONS

A class for three (3) dogs, regardless of sex, of three consecutive generations (grandparent, parent, offspring). The parent and offspring must be entered in another Regular or Non-Regular conformation class. The grandparent may be altered and needs to be entered in any other class unless they are the parent of another 3 Generation unit.

Judging of the 3 Generations: The entry is judged as a unit, with no one outstanding individual outweighing the quality of the others. All are judged on how well they represent the ideal of the breed standard, quality, and consistency. The quality of the dog should meet or exceed that of the previous generation. The judge may make allowances for the expectations based on the dog's age. Class must be entered on the regular entry form as an additional class.

### BEST HEAD, BEST GAIT, BEST OUTLINE

The Special Properties Classes are fun classes which are open to all Scottish Deerhounds of any age or gender and may be altered (spayed or neutered). The dog does not have to entered in a regular class. Enter each class separately by using the "additional classes" box on the entry form or enter by May 7, 2026, at the secretary desk bedside. Each class is \$15.

## SWEEPSTAKES

### SDCA STANDING RULES FOR SWEEPSTAKES & VETERAN SWEEPSTAKES

The handler of an exhibit in the Scottish Deerhound Club of America Futurity or Sweepstakes at the National Specialty shall not be a professional handler or handler's assistant, household member or employee. A professional handler is any person who has been a member of a professional handlers association; listed as a professional handler by the American Kennel Club; has represented themselves as a professional handler; advertised as such, or received compensation for handling dogs at any specialty, group or all breed show within two years of the date of the specialty in which the exhibit is entered. Notwithstanding this prohibition, professional handlers may exhibit, at the national specialty, their own dog(s) of which they are an owner, co-owner, breeder or co-breeder.

For SDCA (Scottish Deerhound Club of America) Sweepstakes, handlers are restricted to owners, co-owners, breeders, or immediate family (spouse, parents, siblings, children) and cannot be professional handlers or

assistants within two years of the event, preventing professional handlers from showing their own dogs unless they're the sole registered owner/breeder;

## VETERAN SWEEPSTAKES

Veteran Sweepstakes will be judged after Puppy Sweepstakes. Veteran Sweepstakes is open to all Scottish Deerhound dogs and bitches who, on the day of the show, will be over 7 years of age. Entrants need not be intact. Dogs entered in the Veteran Sweepstakes MUST ALSO be entered in another class at this show. **OPEN SENIOR CLASS:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show, and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present, it will count as one (1) win towards moving to Open in a licensed or member show.

**MASTER CLASS:** This class will be for Boys and Girls who are at least 9 years old and under 18 years old on the day of the show, and who have won ten (10) Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class, are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

# ALL AROUND HOUND CRITERIA

The All Around Hound award was developed to recognize the Deerhound which excels in all three areas of competition at the National Specialty: conformation, running events, and training events. It takes a special dog and dedicated owner to even compete for this award. Dogs and handlers that excel in all three areas deserve real recognition and we applaud all those competing.

## ELIGIBILITY

Dogs must enter at least one event in each of the following categories:

- Conformation: regular classes, field trial classes, or veteran classes.
- Running Events: ASFA field trial, ACK field trial, or LGRA meet.
- Training Events: Obedience or Rally trial.

## RULES

- Professional handler may not be used unless they are a co-owner of the dog.
- One (1) point will be given for each event (not class) participated in; regardless of performance (qualified score not needed).
- Qualifying scores are required in obedience, rally, the ASFA field trial, and the AKC field trial in order to receive placement points.
- Only the highest scored class in each event will be used for ranking purposes.
- Additional points, as indicated under scoring, will be awarded for every qualifying score earned.
- A dog with a title or legs towards a rally or obedience title may not utilize a score from a lower class for the AAH competition (i.e. if a dog has a CD or legs towards a CD, it may not utilize a score from Beginner Novice). (Exception: when entering both Open/Utility or Advanced/Excellent/Master, the higher qualifying score will be utilized for ranking purposes.) (Exception: dogs categories can declare, prior to start of trial, Veteran Obedience as the counted class).

## SCORING

### RUNNING EVENTS:

ASFA Field Trial and AKC Field Trial:

- All dogs competing in the event (excluding Singles Stake) will be ranked by their total score from preliminary and final runs (run-offs not to count), regardless of stake. If a participating AAH dog ranks in the top 5 scores, points will be awarded as follows: highest score is 5 points then 4-3-2-1. BOB in each trial will receive an additional 10 points.
- If more than 5 dogs compete in the trial, then placement in each class will receive 5-4-3-2-1 (if 6 competing in the class). Point for class placements will reduce accordingly for lower entries. No placement points awarded unless another hound ranks lower.
- Single Stakes points will be awarded as follows: first = 3pts, second = 2.5pts, third = 2pts, fourth = 1.5pts, NBQ/fifth = 1pt. When there are less than 5 dogs, the points will be decreased accordingly. (4 dogs is 2.5, 2, 1.5, 1, etc).
- Tied score: points for tied places will be added together and then divided by amount of dogs titled and all involved will receive that final score.
- All dogs receiving a qualifying score will receive 1 additional point for qualifying. LGRA: Points will be awarded as follows: first = 5pts, second = 4pts, third = 3pts, fourth = 2pts, fifth = 1pt.

### TRAINING EVENTS:

Includes Obedience and Rally

- All dogs competing in the event will be ranked by their score. If participating AAH dog ranks in the top 5 scores, points will be awarded as follows: highest score is 5 points then 4-3-2-1. Additional points for ranked dogs will be added for the competition level completed in as follows: Utility/Excellent 3 points, Open/Advanced 2 points, Novice/Veteran 1 point, Beginner Novice 0.5 point. No additional points for HIT.
- Additional qualifying points will be awarded for each qualifying score as follows: Utility 7 points, Open 5 points, Novice 3 points, Beginner Novice 1 point, Excellent 3 points, Advanced 2 points, Novice 1 point.

### CONFORMATION

- Points from Best of Breed cuts are cumulative but will only be awarded to dogs not receiving BOB/BOS/SELECT/AOM.
- There must be a minimum of 2 dogs in a class for any points to be awarded. The 1<sup>st</sup> place dog in that case would receive 1 point.

The term "dog" refers to either dog or bitch in both Obedience and Rally.

- Qualifying scores are required for all prizes and rosettes in the Regular and Optional Titling classes.
- A Qualifying Score will not be required to earn Ribbons or Prizes in any Non-Regular Class.
- Scores from the Optional Titling and the Non-Regular Classes are not eligible for Highest Scoring Dog in Trial.
- OBEDIENCE AND RALLY TRANSFERS ("MOVE-UPS") WILL BE ACCEPTED ACCORDING TO AKC REGULATIONS.
- No bitches in season may compete. Entry fees will be refunded for females in season. A processing fee may be retained by the Club. (Obedience regulations Chapter 1, Section 14) A refund of all but \$5.00 for bitches in season upon presentation of a written statement from a veterinarian to the Secretary no later than 30 minutes before the beginning of regular class judging.
- A rosette will be given to each entry receiving a qualifying score in the Regular Classes. Qualifying scores required for all prizes.
- Obedience and Rally entries must include jump heights where applicable.
- Entries are limited to **30** in Rally.

- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions, and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.

- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.

The AKC Temperament Test (ATT) was developed to bring focus and provide a meaningful evaluation to assess the temperament of our canine companions.

The ATT tests how a dog reacts to a variety of stimuli. Desirable traits are that the dog will be emotionally stable, inquisitive, cooperative, appropriately social for its breed, biddable and demonstrates the ability to recover from a startling situation in a reasonable amount of time.

Undesirable traits are fear, shyness, lack of cooperation and an inability to recover from unfamiliar or unexpected situations. Examples of undesirable behaviors include being afraid of friendly strangers or unfamiliar stimuli, obsessive barking, and aggression.

In the ATT, dogs are tested in 6 categories of stimuli that include:

1. Social
2. Auditory
3. Visual
4. Tactile
5. Proprioceptive (motion)
6. Unexpected stimulus

PURPOSE OF THIS TEST: The AKC Temperament Test (ATT) is a general temperament test for all breeds and mixed breed dogs that will assess the dog's reaction to a variety of stimuli. These stimuli will be in the following six categories: Social, Auditory, Visual, Tactile (touch), Proprioceptive (motion) and Unexpected Stimuli. The purpose of the ATT is to test for fear, shyness, inability to recover, and lack of cooperation. Desired traits are that the dog will be emotionally stable, inquisitive, appropriately social for its breed, biddable, and demonstrates the ability to recover from a startling situation in a reasonable amount of time. Dogs who show signs of aggression will not pass the test. One purpose of the ATT is to educate dog owners about the temperament of their breeds. At each test, in addition to a title application form and their contact information on the evaluator's checklist, handlers complete the form labeled, "Your Breed's Temperament." The form includes a space for the handlers of mixed-breed dogs to write about the temperament of their individual dogs. Clubs are required to print the Breed Temperament Guide (www.akc.org/akctemptest) and have copies on the registration table and/or a poster.

TEST INFO: The ATT is a noncompetitive pass-fail test. In a test, a dog must pass 3 test items in each of the six categories (total of 18 test items). These are selected from a list of 24 possible test items. All dogs who pass the ATT twice under two different approved ATT Evaluators may earn the AKC Temperament Test (ATT) Title. COLLARS, LEASHES Dogs may wear slip collars that are on the dead ring, buckle collars, martingales and body harnesses in the ATT. They may not wear prong collars, head collars, e-collars, or harnesses that restrict the movement of the dog. Leashes should be 4ft. to 6ft. long and should be made of fabric or leather. For complete AKC Temperament Test (ATT) info visit: www.akc.org/akctemptest

Dogs who are at least 1 year of age are eligible to take the ATT and must either be AKC or FSS registered or listed with Canine Partners or have a Purebred Alternative Listing number. Dogs that are spayed or neutered may participate. Dogs must be able to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), in order to be eligible to earn an ATT title. Dogs with disabilities such as those that are blind, deaf, or have three legs are eligible to enter provided in the opinion of the evaluator they display no signs of physical discomfort and can safely complete the test. However, if a dog has multiple disabilities such that, it is unable to complete whole categories of the test (i.e. - hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title. Bitches in season are eligible to participate but will be placed as the last dog(s) to be tested.

SIGN-IN and CRATING Areas: There will be a secretary table for check-ins and information. Dogs will be crated out of view of the test area, or far enough away as to not cause a distraction to the dog being tested. There is no indoor crating so plan to crate from your vehicle.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Qualifying Score.....Blue/White Rosette

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE: Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
