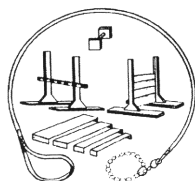

### ENTRIES:

- ~ Entries will be accepted in the order they are received. No entry will be processed until full payment is received.
- ~ **ONLINE PAYMENTS** WILL BE ACCEPTED:  
**PAYPAL** ~ payment can be made thru PayPal (**Treasurer@yabtc.com**). Please include a \$4.00 convenience fee to your total; once you receive your PayPal receipt, include that with your entry form(s) & send an email to Mary (MACDogShows@outlook.com) or fax at 330-599-7185. Include AKC registration number on your PayPal payment so she knows what dog(s) this is payment for.  
**STRIPE** ~ If you would like to make payment via Stripe, email or fax your entry form to Mary asking for an Invoice. This will allow you to pay online. A convenience fee of \$4.00 will be included for EACH event number per dog. Your entry will not be accepted until full payment is received.  
**~NOTE:** If you pay via PayPal or Stripe & you withdraw your entry prior to the closing date, you will receive a full refund except for the convenience fee.
- ~ A Waiting List will be established IF the numerical number of entries is reached. The Waiting List will only be maintained until the trial closing date.
- ~ **Both RACH & RAE classes are offered.** Once the limit has been reached in either the Master, Excellent B or Advanced B classes, these classes will be considered closed.
- ~ **The UDX class is offered on Saturday and Sunday.** Once the limit has been reached in either the Utility B or Open B classes, the UDX class will be considered closed.
- ~ Please indicate on your entry form if you are entering the RACH, RAE, or UDX class.

### COVID-19:

- ~ Although we will not require a COVID release for our trials, we do ask that you respect our workers, judges, & your fellow exhibitors & ask that IF you are not feeling well or have tested positive for COVID, that you not attend our trials.
- ~ If the State of Ohio, Mahoning County, or the CDC make any significant changes at the time of our trials, we will make you aware of our trial changes.

### SET-UP:

- ~ Feel free to bring pop-up tents for shade your dog(s) in your car or in the grass.
- ~ Bring your own chairs. No chairs will be supplied by YABTC.
- ~ **NO CRATE SET UP ON THURSDAY.**

### NO SMOKING:

- ~ NO smoking within 30 ft of the building which includes the doors or inside the building. This includes e-cigarettes, vapes, etc.

### CRATES / POTTY AREAS:

- ~ Ex-pens WITH covers are allowed.
- ~ The Potty Areas are all around the building in the grass. **Do not forget to pick-up after your dog.**

### CATALOGS:

- ~ Only a limited number of catalogs will be printed (Note: the catalog will contain both the **Rally & Obedience entries**. To be sure you will receive a copy, prepay for your catalog by including \$5.00 with your entry fee. To receive your prepaid copy, give your name at the catalog sales table. No catalogs will be mailed. If you purchase a catalog at the trials, the cost will be \$6.00 per catalog.

### FOOD AND BEVERAGES:

- ~ For a small donation, food and drinks will be available on-site. If you desire to eat elsewhere, there are several restaurants locally (Burger King, Dunkin Donuts, Dairy Queen, Subway, Jabs Pizza, Krispy Krunchy Chicken, & CHC Restaurant). You are also welcome to bring your own snacks &/or meals.

## TRIAL REGULATIONS

**ENTRIES CLOSE** AT THE TRIAL SECRETARY'S OFFICE, by 6:00pm, Wednesday, October 7, 2026, after which time entries cannot be accepted, canceled, altered, or substituted. Make check payable to YABTC. Canadian exhibitors must have fees payable in US Funds.

**RETURNED CHECKS** do not constitute a valid entry fee. The Trial Secretary will add a collection fee to the amount of each returned check.

**ENTRY FORM MUST BE SIGNED** by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted.

**OVERNIGHT deliveries** requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement & Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE.

**ENTRY FEE INCLUDES AN AKC RECORDING FEE OF \$0.50** for every dog entered. The **AKC Event Service fee of \$4.00** will be required for each first entry of a dog in Obedience and Rally. The AKC Event Service fee of \$4.50 will be required for each additional entry of the same dog in regular and non-regular classes. These fees are included in the entry fee. (AKC Rule, Chapter 11, Section 2 [Effective 01/01/2026]).

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian/the Judge, or barred from competing by action of the Trial Committee.

**DOGS MAY ARRIVE ANY TIME PRIOR** to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.

**NO ENTRY FEES WILL BE RETURNED** if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the management.

**OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors.

**NO ENTRY SHALL BE MADE** & no entry shall be accepted which specifies any conditions as to its acceptance.

**NO REFUND ON DUPLICATE ENTRIES.** Every effort will be made to find duplicate entries, but if an entry has been processed, no refund will be made.

**BITCHES WHO COME IN SEASON** after the closing date may have their entry fees refunded less \$5.00 per entry upon written certification by a Veterinarian. Notification must be made to the Trial Secretary no later than 10am the day of the Trial.

**WHEN THE SAME DOG IS ENTERED** in more than one class, only the highest score will be used for the top awards in Trial or top awards of a breed.

**DOGS NOT REQUIRED FOR FURTHER JUDGING** will be excused. Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The trial-giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL AWARDS MUST BE CLAIMED DAY OF THE TRIAL** at the Trial or they become the property of the YABTC. **No awards will be mailed.**

**ALL DOGS PRESENT MUST BE HELD ON LEASH** or confined to their crates except when being judged or when in the exercise ring. **All handlers are asked to clean up after their own dog.**

Any requests for Transfers between Rally Trial 1 and Rally Trial 2 on Friday must be received by the Trial Secretary 30 minutes prior to the start of Rally Trial 2. Any requests for Transfers between Rally Trial 2 on Friday and the Saturday Rally Trial, must be received by the Trial Secretary no later than 30 minutes after the last dog completes the respective Trial on Friday or 30 minutes prior to the start of the Rally Trial on Saturday. Any requests for Transfers between Saturday Obedience Classes and Sunday Obedience Classes, must be received by the Trial Secretary no later than 30 minutes after the last dog completes the respective Trial on Saturday or 30 minutes prior to the start of the Trial on Sunday.

### **RAE and RACH Exhibitors:**

When entering Rally Advanced B and Rally Excellent B for RAE qualifying scores, indicate on the Rally entry form RAE entry if you want to enter the trial only if you can get into both Rally Advanced B and Rally Excellent B. If you do so and if one or both of the classes has already filled, your entry (with fees) will be returned. If you enter Rally Advanced B and Rally Excellent B as your classes and have not checked RAE Entry on the Rally entry form, and if one of the classes has already filled, your entry will be accepted for the class that has not filled and your entry fee for the class that has filled will be returned.

When entering Rally Advanced B, Rally Excellent B and Rally Master for RACH qualifying scores, indicate on the Rally entry form RACH entry if you want to enter the trial only if you can get into Rally Advanced B, Rally Excellent B and Rally Master. If you do so and if one or more of the classes has already filled, your entry (with fees) will be returned. If you enter Rally Advanced B, Rally Excellent B, and Rally Master as your classes & have not checked RACH Entry on the Rally entry form, and if one of the classes has already filled, your entry will be accepted for the classes that have not filled and your entry fee for the class that has filled will be returned. **From West:** Take I-76 East to the Bailey Road exit. Turn South (right) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. Trial site is about one mile on right hand just past the blue water tower.

**From East:** Take I-80 West which will merge with I-76 West. Proceed two miles after the merger to the Bailey Road exit. Turn South (left) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. Trial site is about one mile on the right-hand side just past the blue water tower.

**From Ohio Turnpike:** Take the Turnpike to Exit 218. At the exit, follow signs to Mahoning Avenue. Proceed to Mahoning Avenue West. At the light (Route 45), continue on Mahoning Avenue crossing over Bailey Road. Trial site is located on the right-hand side just past the blue water tower.
